**GRUPO AEROPORTUARIO DEL PACIFICO, S.A.B. de C.V.
ANNOUNCES PRELIMINARY INJUNCTION AFFECTING CORPORATE
GOVERNANCE**

Guadalajara, Jalisco, Mexico, July 21, 2010 - Grupo Aeroportuario del Pacífico, S.A.B. de C.V. (NYSE: PAC; BMV: GAP) (the "Company" or "GAP") announces the following:

During a systematic review of local and federal courts in search of any outstanding claims that may be pending against the interests of the Company, the Company's legal representatives discovered proceedings related to a preliminary injunction that could affect the Company's corporate governance. These proceedings were brought before a local law judge in Mexico City. Although GAP has not been officially served with notice of these proceedings, the Company was informed of their existence by legal representatives of Controladora Mexicana de Aeropuertos (CMA), the Mexican partner of our strategic shareholder.

The Company believes its corporate organs comply with applicable law. Accordingly, in order to protect the interests and security of the rights of its shareholders, and in compliance with the Company's bylaws and applicable law, the Company has decided to bring this matter before the Federal Courts of Mexico for a review of the legality of these measures. As a result, the Company does not expect there to be any significant disruptions in the normal operations of the Company's governing bodies.

Company Description:

Grupo Aeroportuario del Pacífico, S.A.B. de C.V. (GAP) operates 12 airports throughout Mexico's Pacific region, including the major cities of Guadalajara and Tijuana, the four tourist destinations of Puerto Vallarta, Los Cabos, La Paz and Manzanillo, and six other mid-sized cities: Hermosillo, Bajío, Morelia, Aguascalientes, Mexicali and Los Mochis. In February 2006, GAP's shares were listed on the New York Stock Exchange under the ticker symbol "PAC" and on the Mexican Stock Exchange under the ticker symbol "GAP".
